Annual Title 1 Parent Meeting

Purpose:

- To inform parents and families of their school's participation in the Title I, Part A
 Program
- To explain the requirements of the Title 1, Part A program
- To explain the right of parents to be involved in the school's program

Title 1, Part A Program

- The purpose of the Title I, Part A Program is to improve student academic achievement.
- All WISD campuses are considered Title 1, Part A due to high numbers of economically disadvantaged students.
- Our goal is for all students to <u>MEET</u> or <u>EXCEED</u> the state performance standards.
- Every WISD parent has the right to be involved in their child's education.



Title I, Part A, Program

The <u>Student Achievement Plan</u> addresses how the district will use Title I, Part A funds within the school district and at each campus. Typically, in Texas, the requirements of the Title 1 Plan are incorporated into the District Improvement Plan (DIP) and Campus Improvement Plan (CIP).

Topics in the SAIP include:

- High-quality student academic assessments
- Supplemental services to assist struggling students
- Coordination and integration of federal funds and programs
- Strategies to implement effective parent and family engagement
- Title 1, Part A parents have the right to be involved in the development of this plan

Title I, Part A, Budget 2018-2019

- Weslaco ISD receives and annual entitlement that is distributed to Weslaco ISD programs and schools each school year.
- Each year the district is required to submit a consolidated federal grant application that provides the program description and how the funds will be spent.
- All schools in Weslaco ISD are Schoolwide Program Campuses.
- Schoolwide Programs allow schools to use Title I, Part A funds for the overall improvement of teaching and learning for all students in the school.
- The focus for Title I funds is to support students who are in need of additional assistance in order to meet or exceed state performance standards.



Title I, Part A, Budget 2018-2019

In Weslaco ISD Title I funds are used for:

- Staff
- Family Engagement
- Support for Students
- Staff Development

Title I, Part A, Parents Right To Know

Parents' Right to Know-Teacher and Paraprofessional Qualifications: Schools must inform parents of Title 1, Part A that they have the right to request information regarding the qualification of their student's classroom teachers and paraprofessional providing services to the child. (Section 112 (e) (1) (A)(i-ii))

- Parents must follow the school procedure to request this information
- Check with your school office or district office to make this request.

Parents' Right to Know - Non State Certified Teachers: Schools are required to notify parents that the student has been assigned, or has been taught for 4 or more consecutive weeks by, a teacher who does not meet applicable State certification requirements at the grade level and subject area in which the teacher has been assigned. (Section 1112(e)(1)(B)(ii))

Parents' Right To Know-Student Achievement: Schools are required to provide each parent information of the level of achievement and academic growth of the parent's child in each of the State Academic Assessments. (Sections 1112(e)(1)(B)(i))

School Curriculum

Weslaco ISD teaches the Texas Essential Knowledge and Skills that are required for all schools in the state of Texas.

Weslaco ISD monitors student progress using formative and summative assessments

- Formative: teacher created assessments, computer based assessments, teacher observation, [school may add other types of formative assessments]
- Summative: State of Texas Assessments of Academic Readiness (STAAR),
 curriculum-based common assessments, district benchmarks

- Convene an annual meeting
- Provide a flexible number of meetings
- Involve parents in an organized, ongoing and timely way, in the planning, review, evaluation, and improvement of the parent and family engagement policy and program
- Provide timely information about parent and family engagement activities
- Provide information to parents about curriculum and assessment

School Student Parent Compact

The school-parent compact is a written agreement....

- That describes how parents and families, school staff, and students share the responsibility for improved student academic achievement
- That address high-quality curriculum and instruction to meet State academic standards
- The ways in which parents will support their child's learning
- Communication between school and home, and the value of parent/teacher conferences (required at elementary school.) (Discuss the parent/teacher conference)
- Title 1, Part A parents have the right to be involved in the development of the school-parent compact
